If any defects in material or workmanship shall be discovered in the work furnished or material used during the course of the work or within one year from the date of the Certificate of Completion, the undersigned agrees to replace or correct such defective work or material, free from all expense to Lowe's and the Customer in a manner satisfactory to the Customer.
